



# School Fees Terms & Conditions

## **Dear Parents,**

Welcome and best wishes for the new Academic Year at the Sohar International School.

Please take note of the following terms and conditions which apply to the payment of school fees this coming year.

## **Payment**

1. Parents have three options of paying fees

A - One Payment for the year.

B -Three payments, 1<sup>st</sup> September 2013, 31 January 2014 and 31 March 2014

C – Seven monthly payments-in advance at the end of each month and before the 7<sup>th</sup>.  
The final Payment for this option to be the 31<sup>st</sup> of March 2014

2. Payment in three and seven parts must be made with post –dated cheques

3. Please notify us if your company will be paying the fees, in order for us to prepare the relevant invoice.

4. All the school fees must be paid during the academic year.

5. Capital levy must be paid on or before 4<sup>th</sup> September 2013 – End of the 1<sup>st</sup> week of school.

6. For students of KG1 to G4 the stationery fee must be paid on or before 4<sup>th</sup> September 2013 – End of 1<sup>st</sup> week of school.
